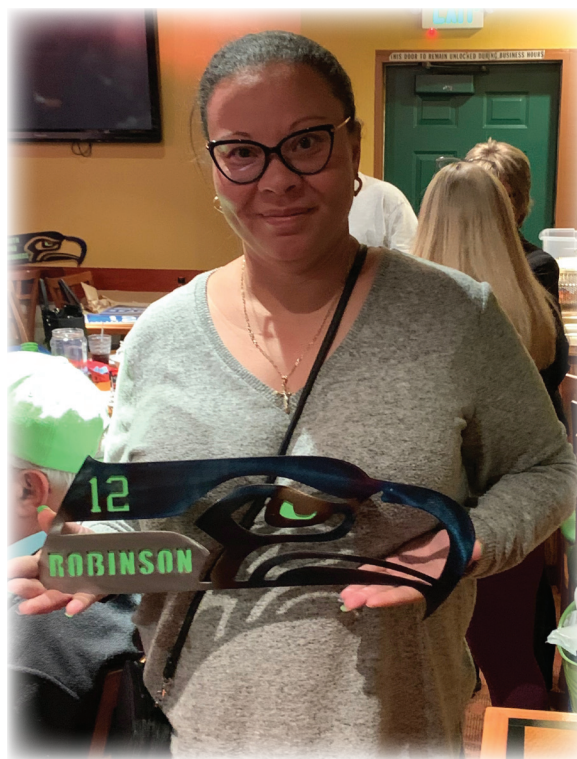
JANUARY SPEAKER

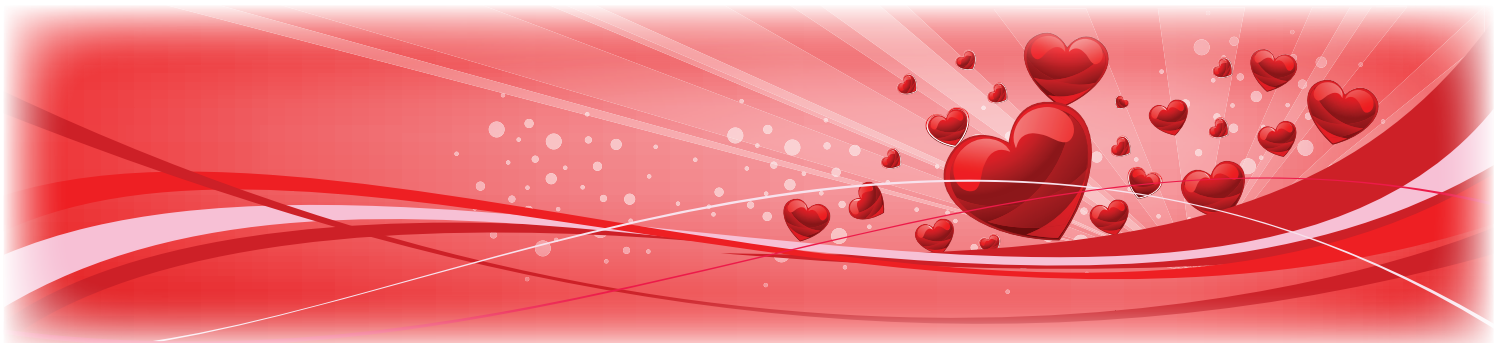

Once again, this year the NFL and your Seattle Seahawks are offering to Sea Hawks Booster Club members in good standing that are part of a Sea Hawks Booster chapter in good standing the opportunity to participate in the 2020 NFL DRAFT EXPERIENCE in Las Vegas Nevada.

It has not been disclosed at this time just how many tickets both INNER CIRCLE and GENERAL ADMISSION will be available to us for the 3 days.

INNER CIRCLE PASSES

INNER CIRCLE PASSES ARE WITHIN A VIP AREA WHERE ALL 32 TEAMS HAVE THEIR OWN DESIGNATED AREAS. THE ANNOUNCEMENT STAGE FOR THE DRAFT IS IN THIS VIP AREA.

This group of fans are REQUIRED to be dressed in their Sunday Game Day best SEAHAWK GEAR with their game day LOUDEST 12 VOICES AND ENTHUSIAM. THE LOUDER YOU ARE THE BETTER CHANCE OF GETTING OUR DRAFT CHOISE TV TIME.

Members, winning the lottery for this area, must understand, you are required to stay in this area. You will enter this area as a group and cannot enter the area late It will be long days, however there are concession stand for you to buy food and beverages and restrooms in this area. Bring money and be prepared to stay the course. You cannot leave the area as there is no re-entry and your wrist band is not transferable to anyone else. If you choose to leave the area, your spot will be filled by a member from the General Admission area by myself or the team. There is a good possibility if we have an abundance of members going we might switch out the groups half way through the days, so everyone gets a chance to attend this fun event.

2. All applicants MUST be a Sea Hawks Booster member in good standing with a Sea Hawks Booster chapter in good standing. This will be verified.
3. All members that wish to attend the 2020 NFL DRAFT EXPERIENCE in Las Vegas will fill out the attached application completely. Incomplete applications will NOT be processed. Applications will be accepted only via email. You must provide the following: day(s) you are available, chapter name, member name, physical address, email address and cell phone number. If you are a couple, either husband or wife, friends, brothers, sisters, cousins, friends please list all information for both members. with a maximum of 2 names on each application. YOU MAY NOT BRING GUESTS.
4. You must be able to fund your own airline travel, train travel, bus travel and hotel accommodations. Food and drink are on your own.

5. If your name is drawn for the lottery you will be REQUIRED TO PROVIDE your Airline Reservation, hotel reservation. There will be no exceptions.
6. If you are chosen to attend either INNER CIRCLE or GENERAL ADMISSION you must be on time for all check in times as you will be escorted by NFL volunteers, If you are late you will be replaced by the next name on list. Remember we only have so many tickets. We will have a waiting list for GENERAL ADMISSION.
